Instructions for filling out the Application For Compliance Decals

Follow the procedures below. The numbers of these procedures correspond to the numbered items on the *Application For Compliance Decals*.

1. **(a)** Enter your last, first, and middle name as it appears on your driver's license, AND **(b)** Enter the corporate name as it appears on your Section Five Registration and on any IRS form that contains your EIN or FID.
2. **(a)** Enter your driver's license number or the words "no license" AND **(b)** Enter the Employer Identification Number (EIN) or Federal Identification Number (FID) as it appears on any IRS document you have.
3. Enter the address of the business as it appears on your Section Five Registration.
4. Select the appropriate Section Five Registration type.
5. Enter the registration number.
6. Enter the following vehicle information for each vehicle. (For vehicles that are titled, use the information that appears on the title.)

VIN: Enter the 17-character vehicle identification number for automobiles and trucks. For other vehicles, enter the first 17 characters of the manufacturer's vehicle identification number.

Title Number:

Enter up to eight digits for the title number as issued by the Massachusetts Registry of Motor Vehicles, if applicable.

Year: Enter the year of manufacture (for example, 1983, 1988)

Make: Enter the make code (for example, chev, ford). This is a maximum of four characters.

Model: Enter the model name or number. This is a maximum of five characters.

Body Style:

Enter the two-character body style. Select the appropriate style from the attached list and write in a description.

Horsepower:

Enter the horsepower.

Gross Vehicle Weight:

Enter the weight in whole pounds.
